

CSEM is calling for nominations for **President-Elect** and **2 Director positions** on Council. Council members play an integral role in the growth and success of our organization. We're looking for enthusiastic and committed CSEM members with strong leadership abilities, and collaboration and communication skills. We want members who can help develop and deliver programs, and who are connected to the endocrine and metabolism community. Council advises the membership on matters related to governance, public policy, committee representation and strategic direction of the Society.

CSEM is recruiting Council members who collectively reflect the diversity of the endocrine medical and research community, including constituent geographic areas, as well as all areas of endocrinology (i.e.: adult, pediatric academic, community and research), skills and experience. We strive for inclusivity and discourage discrimination based on, but not limited to, gender, language, race, cultural background, sexual orientation, age, and ability.

### **Eligibility Criteria**

Nominees must be:

- Active CSEM members. Affiliate and emeritus members are not eligible.
- Enthusiastic and committed to developing and delivering excellent programming.
- Able to work with a group to achieve results.
- Connected within the endocrine and metabolism health and research network.
- Collaborative and demonstrate strong communication skills.
- Knowledgeable about endocrinology and metabolism health, care and/or research.

### **Selection Process**

- The CSEM Nominating Committee reviews all candidates according to eligibility criteria and diversity considerations.
- The Committee proposes a slate of candidates to CSEM Council and members for approval at the 2025 Annual General Meeting in November.

## **PRESIDENT-ELECT**

### **Term**

- 4 years, the first 2 as President-Elect, the second 2 as President. Upon expiry of the term as President, the Council may appoint the Director as Past-President.

### **Roles and Responsibilities of the President-Elect and President**

The President-Elect is an Officer and Director of CSEM and assists the President with general oversight of CSEM's affairs. The President-Elect acts as Chair of the Program Planning Committee and is responsible for planning the CSEM scientific content for the annual Diabetes Canada/CSEM Professional Conference.

The President is the chief Council Officer and exercises general control and supervision of CSEM's affairs. The President chairs CSEM Council and presides over the Annual General Meeting. He or she works closely with CSEM's executive director and the Council Executive, providing general oversight and leadership of CSEM.

## **COUNCIL DIRECTORS**

### **Term**

- 3 years, from AGM 2025-AGM 2028, once renewable

### **Role and Responsibility of Directors**

- Act as a CSEM ambassador, promoting CSEM's activities to its members, prospective members, the public and stakeholders.
- Identify the priority needs of our members and the resources required to achieve them.
- Identify and understand emerging issues and opportunities for the profession.
- Represent the interests of CSEM's geographic or practice areas.
- Assist in updating and reviewing CSEM's mission, strategic plans and goals.
- Participate in Council calls and meetings, other committees and projects.
- Attend the in-person Council meeting during the Professional Conference.
